SL No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 16, of which not more than 1/3rd sections may be used for senior secondary classes. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	The ramp to access the upper floors has been shown in the video; however ramp at the entrance was not shown. The school is required to make provision with proper possible infrastructural facilities for CWSN students to access upper floors by a ramp or lift as prescribed by the RPwD Act 2016 and circular no. 5 dt. 6.3.2023 issued by the Board and submit the compliance through videography within 3 months on the SARAS portal.
3	Only two CWSN toilets were seen in the videography. The school should make provision for CWSN toilets, separately for boys and girls on every floor as per RPwD Act and submit the compliance through videography within 3 months on the SARAS portal.
4	There is no seating arrangement in the sports room, thus the school is required to make arrangement for seating and submit videographic proof within 3 months on the SARAS portal.
5	The school is required to increase the stock of books in the Library and submit the compliance through videography within 3 months on the SARAS portal.
6	There is no seating arrangement in the Physics, Chemistry and Mathematics lab, thus the school is required to make arrangement for seating and submit the compliance through videography within 3 months on the SARAS portal.
7	The system generated self-certificate has not been signed by the Principal and Manager of the school. The school is required to upload the certificate duly signed by all concerned in mandatory public disclosures and submit compliance within 3 months on SARAS portal.

The school shall ensure the training of its teachers with CoE Bhubaneswar within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.

3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
